HISTORICAL NOTES

article reprinted from the AAPOA July 2005 Newsletter

There are fewer regional residents dating back to 1963 when John Eaton (lumberman) of Rochester, Vermont envisioned the community of AuSable Acres. It's time for the new residents to become aware of the foundation of the original 5,000 acre development.

Under the sales management of Bernard Roberts, high gloss ads appeared in major city newspapers. AuSable Acres sales gave a low profile approach to a bit of 'Eden' in the Adirondacks. With little money down, \$10 would hold a building lot and financing through the Acres with a 5 year loan. Individuals from Montreal to New York City, Long Island and New Jersey could achieve the American dream of owning a second home in the mountains.

Dick Champeny, Manager, would oversee the building of almost any style or design of Chalet, Camp, A-Frame or Cedar Pan-Adobe. This is why there are many variations of structures in the Acres. Dick and his staff were extremely agreeable and willing to make your new home to your liking and taste. If any problem arose, the crew was immediately sent to your home to correct the

situation. Opening and closing the house was provided by the office staff. Cleaning and renting service was also available. A phone call to Polly Andrews at the office was all that was needed and the job was completed.

Pale Face Dude Ranch on route 86, owned by Doc and Jean Fitzgerald, provided indoor swimming and horseback riding through the trails in the Acres. An intermediate ski lift was also available at the ranch. The Fitzgerald's were labeled number two hosts as John Eaton was considered the best host in the North Country.

The Acres flourished the first six years. 100 homes were constructed. A flight strip was maintained parallel to AuSable Drive. Two tennis courts were created. In 1967, the Homeowners Association stocked the lake with speckled trout. 1969 records indicate a Cliff Jennewein,

President of the Homeowners Association, presided at a meeting held at the lake. This was followed by a community barbeque attended by as many as 300 residents. Vivian Burdick's baked beans made a press release in the September 1970 publication of AuSable Acres News.

The second slate of officers were: President Bot and Claire Ham and Vice President Joe and Norma DiMarco, Secretary Ray Doyle and Treasurer Bart and Wanda Gaffney. These four families still live in the Acres. They worked with a budget of \$3,577 with Homeowners paying \$10 and landowners dues of \$5 per year.

John Eaton provided total maintenance of the roads, free water and maintained the recreation areas. He wanted others to love and enjoy the Adirondacks.

We will attend to the tennis court vandalism soon. The case is in court and the damage will be fixed once the weather is warm enough. The board and I hope that we won't have to deal with any further damage to our property.

The town supervisor, Randy Douglas, successfully applied for a grant from NYS to bring broadband Internet service to the Acres through Charter Communications. Details of the when and how will be forthcoming soon. Stay tuned. We have been waiting for this for a long time.

Thank you for your support of the AAPOA and AuSable Acres. Your membership dues are the only income source we have to maintain and improve our amenities. A special thank you to our members who have made extra donations when paying their dues. We really want AuSable Acres to be a wonderful community for many years to come.

Despite the fact that we currently reside in Pennsylvania, Katie and I are contemplating becoming fulltime residents shortly in order that we can come 'home' to the natural splendors of the Adirondacks and savor the peaceful ambience afforded by the Acres lifestyle.

WILDLIFE IN AUSABLE ACRES

We live in an area that was forested and without any houses until the 1960's. This was home for a variety of wildlife. Many of these animals and birds can still be found here. In the past year, we have seen many deer and raccoons. Before the ice storm of 1998, deer were seldom seen in the Acres. The storm destroyed the tops of many trees allowing the sunlight to reach the forest floor. This,

in turn, has allowed brush and vegetation to grow, which gives cover and food to the deer.

In April, we were surprised when a handsome coyote walked by our garage window!

Once, we looked out and 12 turkeys were under the feeder. It also attracts squirrels, chipmunks, mourning doves, chickadees, nuthatches, blue jays, tufted titmouse, grosbeaks, gold finches and juncos. Even bears like the sunflower seeds, but they tend to destroy the birdfeeders. The suet feeder attracts many woodpeckers including the large pileated woodpecker which can be up to 15 inches tall.

One of the most fearsome animals that had been on our property is the fisher, which is related to weasels, minks and wolverines. In the past 19 years we've seen four in our yard, but many more on AuSable Drive. To our dismay one of their favorite foods is cats. One morning we heard a commotion and looked outside to see a large fisher dragging our cat by its neck towards the woods. My wife ran after it with a broom and I was able to rescue our cat. With Dr. Sue's help, she made a full recovery. We had lost other cats before we realized what was happening to them. Now, our cats are indoor pets!

Before the Acres was developed, my father trapped this area for fishers. He only caught a few because they were rare. They had been overtrapped back then because their hides were worth over \$200 each (a large amount for the time). Fishers have made a comeback because there is no longer a demand for their fur. The last I checked, they brought \$20.

This past winter, a porcupine had taken up residence in a dry culvert on AuSable Drive. I saw him many times on my way to work in the morning, sunning himself outside his manmade den. Foxes are also a common sight in the Acres, often with kits in tow.

150 LOT PROJECT

Several years ago JLKN purchased several thousand acres surrounding AuSable Acres. They acquired all the land that had not been previously subdivided by the Eaton family when they first began selling property in the Acres in 1963. JLKN's holdings run along Cross St, parts of Sawmill Drive, parts of AuSable Drive and part of the area known as the Cascades. There are other parcels, as well, but these are the largest. JLKN could subdivide the property and sell building lots in the future. This is the reason for the 150 lot project. A short history follows as well as the steps that you can take to insure the existence of the AAPOA and its amenities permanently.

HOW DID THE JLKN AGREEMENT HAPPEN? When John McAlevey, our former attorney and board member, realized the Eaton family was selling their holdings in AuSable Acres, he was concerned about maintaining our right to use the amenities that were promised to AAPOA members at the time they bought property. He solicited original owners and asked them to sign Quit Claim Deeds to ensure our permanent rights to use the trails, lake and river accesses as promised. In order to remove the Quit Claim Deeds and clear title, JLKN sued the AAPOA. Negotiations between JLKN and the AAPOA resulted in the AAPOA securing its right to the amenities mentioned above. The 150 lot agreement is part of the larger agreement between the AAPOA and JLKN.

WHAT IS THE 150 LOT AGREEMENT AND WHY IS IT IMPORTANT? The 150 Lot project is an agreement between the AAPOA and JLKN that stipulates if 150 AuSable Acres home/lot owners agree to make their AAPOA membership mandatory, JLKN will be bound to make all of their future home/lot owners mandatory members. If JLKN develops their land prior to 150 AAPOA members signing-up for mandatory membership, their homeowners have use of the lake and trails without paying AAPOA dues since the lake and trails are officially on JLKN land. In addition, the JLKN homeowners could start their own property owner's association which could compete with the AAPOA. This is an important agreement as it guarantees a strong base of dues paying members into the future.

HOW AM I AFFECTED IF I BECOME PART OF THIS? When you sign-up for the '150 lots' you agree to make your AAPOA membership mandatory for you and future owners of your property. An important fact of this agreement is that AAPOA members who sign-up for the 150 Lot project are only bound to mandatory membership if and when JLKN develops their land.

Approximately 75 of your neighbors have guaranteed their AAPOA membership. We hope you

support this important initiative and ask you to go to our website and click on the '150 Lot' info heading and download the notary form. Complete the notary form including your name, local address, Tax ID number and deed reference which are located on your annual tax bill. If you don't know your ID numbers, we'll use your address to research. Have the form notarized and mail to AAPOA, PO Box 8, AuSable Forks, NY 12912. The AAPOA will file the forms and have your deed amended at no charge.
